### EXECUTIVE SUMMARY

Murrumbidgee Council hold Seniors' Week activities annually across Darlington Point, Coleambally and Jerilderie. Planning is underway for March 2024 celebrations, however no grant funding allocations were awarded to complement Council's 2024 budget allocation.

Currently Council has a budget of \$3500 for events across the Local Government Area.

### RECOMMENDATION

That:

- a) **Council endorse the increased funding allocation for Seniors' Week activities to \$7,500.00, with additional \$4,000 funding to come from Council's unrestricted fund; and**
- b) **A Seniors' Week event be held in each of the three Murrumbidgee communities.**

### BACKGROUND

Murrumbidgee Council recognises our senior residents for their valued contributions to our community.

Annually, Council celebrates Seniors' Week with a range of activities. Past programs offered in our area include, but are not limited to, luncheons, themed occasions, morning/afternoon tea, intergenerational activities, movies, wellbeing sessions and physical activity.

The planning for the 2024 Murrumbidgee Council Seniors' Week celebrations are underway, however staff are working on activities based on the Council allocation of \$3,500, having been unsuccessful in obtaining Government funding.

## **OFFICER COMMENT**

Council is the project manager for the event, with overall authority in facilitation and risk management.

An increase in the budget allocation from \$3,500 to \$7,500 for the 2024 activities, would ensure quality and meaningful events can be offered locally to seniors residing in each of our three communities.
