#### **BACKGROUND**

Council has agreed to a land swap with Waddi Housing and Advancement Corporation.

Council, prior to any request from Waddi Housing, selected 6 and 9 Edwards Street to swap for 31 Carrington Street, Darlington Point.

At the October Council meeting I presented correspondence from Waddi Housing and Advancement Corporation indicating they selected 47 Helena Parade and 1 Young Street, Darlington Point. Council decision was to offer the original lots as adopted at the October Extraordinary Council Meeting (being 6 and 9 Edwards Street).

## **RECOMMENDATION**

#### That Council:

- 1. Repeal its offer of two lots within the Young Street subdivision, identified as 6 and 9 Edwards Street Darlington Point, to Waddi Housing and Advancement Corporation Ltd;
- 2. Offer to Waddi Housing and Advancement Corporation Ltd two lots within the Young Street subdivision, identified as 47 Helena Parade and 1 Young Street, Darlington Point:
- 3. Complete the purchase of lot 4, DP 718198, 31 Carrington Street Darlington Point from Waddi Housing and Advancement Corporation Ltd for the Long Day Care Centre.
